The Ilanka Community Health Center Registered Nurse provides support and assistance to medical providers and coordinates direct patient care while facilitating patient flow within the clinic. Ilanka Community Health Center promotes a team based approach to care.

This position establishes methods and procedures for attaining specific goals and objectives, and receives guidance in terms of broad goals. Only the final results of work are typically reviewed.

## **Responsibilities/Duties**

- Provides direct patient care:
  - Assesses patients for urgency of needs and prioritizes by acuity in a professional and friendly manner.
  - Maintain a high level of confidentiality, which includes only accessing appropriate information needed to perform job duties.
  - o Follows standard precautions.
  - Maintains exam room protocols and ensures rooms are stocked and cleaned in a timely manner as specified by clinic procedure.
  - Starts intravenous infusions, takes vitals, performs 12 lead EKG and rhythm strip, fits heart holster monitors, sets up and administers nebulizers, administers injections, performs vision and hearing tests.
  - o Collects laboratory specimens including phlebotomy.
  - o Initiates and coordinates referrals when Care Coordinator is unavailable.
  - o Responsible for lab result notification and documentation.
  - o Assists with infectious disease reporting.
  - o Documents and administers vaccinations.
  - Completes required training to act as primary or secondary administrator of the vaccine program.
  - O Sets up and assists medical providers with procedures and treatments including minor surgical procedures, wound/burn care, and well-women exams.
  - o Ensures all necessary equipment is sterilized per AMA best practices.
  - o Performs CLIA waived lab tests.
  - o Implements standing orders, as approved by the Medical Director.
  - o Prioritizes phone calls and returns call within designated guidelines.
  - o Participate in clinical team huddles daily.
- Assesses patient's knowledge base and learning style and provides patient teaching as needed or requested.

- Responsible for dispensary inventory control and purchasing of medications/prescriptions and other dispensary supplies. Implement and maintain dispensary regulatory standard, policies and procedures, monitoring equipment and request required maintenance. Maintain dispensary organization, labeling and cleanliness.
- Responsible for crash cart inventory control and purchasing of medications/prescriptions and other supplies. Implement and maintain crash cart regulatory standard, policies and procedures, monitoring equipment and request required maintenance. Maintain crash cart organization and labeling.

- Primary or secondary for employee health records and maintenance, vaccination and declination tracking on a regular basis. Implement and maintain regulatory standards, policies and procedures.
- Maintains accurate and appropriate records and documentation of nursing care.

- Assist providers in using and troubleshooting electronic medical records software.
- Use Electronic Medical Records for day-to-day record keeping, which includes accurate entry/scanning of information into patient charts as well as ensuring information is only released to authorized entities.
